JAN. 1 REMINDERS: BUSINESS TAX, MINIMUM WAGE



With the passage of Measure K, the City is implementing a new business tax. Notifications to businesses have already been sent and are continuing. The first payment is due January 1, 2024.

On January 1, 2024 the new minimum wage in the City of Palo Alto will be \$17.80, and applies to all employees who work at least two (2) hours per week within Palo Alto. Employers must post the official Palo Alto Wage Bulletin in workplace informing employees of current minimum wage rate and their rights.
