Since then Palo Alto has been stuck with unpopular, restrictive, confusing, and fundamentally unworkable cell tower standards. Standards which were overturned by the Ninth Circuit two years later.



Dear Palo Alto City Council,

I am writing to support the proposal from Ed Lauing and Lydia Kou regarding wireless equipment reviews. Beyond aesthetics, the city should proceed with great care and caution when approving wireless equipment.

The carcinogenic and toxic effects of EMF are well-documented in Martin Blank's book [Overpowered](#), which I encourage you all to read since you are indirectly and directly responsible for the health and welfare of Palo Alto's citizens. Research has shown that exposures of EMF at levels the government has deemed "safe" for just two hours increase the frequency of DNA strand breaks in the brain cells of living rats, continuing even after the exposure ended. Exposure causes immediate damage and unleashes a chain of processes that continue damage well after the exposure itself.

Many other studies have found similar genotoxic effects resulting from EMF exposure. The presence of micronuclei as a result of RF radiation (such as that emitted by cell phones) indicates a type of DNA damage so strongly associated with cancer that doctors test for them as a means of diagnosing cancer.

Yet another study by Dr. Neil Cherry demonstrated that living closer to broadcasting antennas correlates with a higher incidence of childhood cancer and that the risk for such cancer drops significantly with increased distance from such antennas.

EMF radiation in the environment has been linked to increased risk for Alzheimer's, autism, cancers including leukemia and glioblastoma, neurodegenerative diseases, infertility, depression, and suicide. It decreases the production of melatonin and erodes the blood-brain barrier. The ubiquitous presence of EMF, cellphones, and WiFi may be contributing significantly and invisibly to the epidemic of these conditions and chronic illness today.

For those of us who care about health, wellness, and longevity for ourselves and our loved ones, this problem seems intractable and beyond our control. Policy set by the city council is one thing we *can* do to protect the safety and welfare of people more generally. Thank you, Ed and Lydia, for fighting for Palo Alto's residents.
